

OK FURNITURE BIG BRANDS SALE 2026 COMPETITION TERMS & CONDITIONS

1. The promoter is OK Furniture and OK Power Express (South Africa) a trading division of Shoprite Checkers (Pty) Ltd ("the Promoter").
2. The promotional competition is open to all South African residents and who are in possession of a valid identity document, passport or document of proof of South African of residency, as the case may be. Any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members may not enter or participate in the Competition and will automatically be disqualified upon entry.
3. Any participant under the age of 18 (Eighteen) years must be fully assisted by his/her parent or guardian, who approves of and consents to such participant's participation in the competition and such participant's receipt/possession of the prize.
4. This promotional competition is open from 23 March 2026 and ends at 12am (midnight) on 24 May 2026. Any entries received after the closing date will not be considered. Selected winners will begin to be notified 4 (four) weeks after the campaign has ended.
5. To enter, participants will be required to:
 - 5.1 Purchase any of the participating brand items (listed at the end of these terms and conditions) cash or on credit, from any of our OK Furniture or OK Power Express stores to be automatically entered into the competition;
 - 5.2 Lay-by purchases do not qualify for this competition.
 - 5.3 *Purchase any of the participating brand items on cash and carry and scan the QR code in-store to register to enter into the competition. See in-store leaflets for more details. Participants registering via the QR code, must enter in their correct contact details. If a winner has given incorrect contact details, the Promoter reserves the right to select another winner in terms of the rules.*
 - 5.4 Participants will receive 1 (one) entry for every invoice that includes products from any of the 25 participating brands.

Therefore, as an example: a participant purchases 3 (three) of the participating brand items (1 x Hisense brand, 1x Samsung brand, 1 x Restonic brand) in one transaction, one entry for that specific transaction. If a participant goes back for a second purchase the next week, of another Samsung brand (1 item), the participant will receive another entry into the competition.
6. Participants must keep their invoice or delivery note as proof of purchase.
7. Participants could win 1 (one) of 16 (sixteen) Toyota Vitz 1.0 litre MT (52U) up until 24 May 2026 or when the competition ends, should it be earlier than the defined closing date. The aforementioned 16 vehicles are the total number of prizes in the competition.

8. The prize is not transferable or exchangeable for cash.
9. All winners will be required to provide their full names, ID numbers and contact details and to sign an acknowledgment of receipt of the prize.
10. Winners will be selected by means of a random draw. There will be one draw for each participating brand. Winners will be notified telephonically and will be required to verify their details. The Promoter (or their agent) will endeavor to contact the prize winner once every day for 5 (five) consecutive working days after their name is drawn. If the prize winner cannot be contacted during this period, the prize will be forfeited, and another winner will be randomly selected in accordance with the rules.
11. Failure to claim a prize within a period of 2 weeks after being contacted and/or a refusal or inability to comply with these terms and conditions will result in the disqualification of the relevant winner and a new winner will be drawn in their place at the sole discretion of the Promoter.
 - 11.1 The winner must have a valid driver's license or, if not, they should be accompanied by a person with a valid driver's license.
 - 11.2 The prize is inclusive of once off licensing and registration fees. The winner will be responsible for insuring the vehicle at their own expense.
 - 11.3 The Promoter will not be held liable for any additional expenses incurred.
 - 11.4 The Promoter will endeavour to hand the prize over to the winner within 8 weeks after the end date of the promotion. In the event that the prize is not available despite the Promoter's reasonable endeavours to procure the prize, the Promoter reserves the right to substitute the prizes of equal value or deliver the prize as soon as a replacement prize can be made available.
 - 11.5 Once the Promoter is ready to hand over the prize, the winner will be notified of the specified prize details, and they will need to travel to the selected store which they entered the competition to receive the prize or nearest local dealership as directed by the Promoter. Further details on licensing and registration will be arranged by a representative of the Promoter and communicated to the winners.
 - 11.6 Winners will only be selected within the jurisdiction that they entered, no participant will be eligible to win outside of the jurisdiction in which they had entered.
 - 11.7 The winner may not nominate another person to collect the prize on their behalf.
12. The Promoter shall not be liable for any manufacturing faults, recalls, damage or loss of or to any vehicle once handed over to a winner.
